2010 was a year of monumental growth for First Descents. Despite the poor economic outlook nationally, First Descents was among the few nonprofits that actually grew revenue in 2010-- by 36%.

We grew the number of programs offered from 9 to 15, an increase of 67%.

The one thing that didn't grow significantly in 2010 was overhead. Administrative and Fundraising expenses grew less than 2% over 2009.

We closed out 2010 with a new logo, fresh brand look and very promising first year results from our Team FD online fundraising platform.



A message from our Founder/CEO:

2010 marked a tipping point for First Descents. It was our 10th year of programming, until that point we always seemed to have been going against the current, but the tides began to shift and our momentum increased. This allowed our talented staff to start focusing on new and exciting challenges. In the face of this new traction and growth we were forced to develop a new programming model that was more scalable. We began to pour fuel on the fire that is TEAM FD; we watched as our captain, Ryan Sutter, redefined “challenge” by taking on 10 grueling events in the course of a year, with the goal of raising \$100k for FD. He succeeded, and in doing so, he inspired countless others to follow. We relocated our headquarters to Denver so that we could have access to more resources and an airport that accommodated the ever-growing amount of travel we do. Most importantly, we hosted a record number of participants at our programs, and their testimonials affirmed what we believe: First Descents really does empower its participants to defy cancer and live beyond their disease.

All of this momentum, invention, innovation, inspiration, adventure, challenge and life has been created from the passion of the people who believe in, support and volunteer for First Descents. Our progress is fueled by you and it is you we thank for our successes!

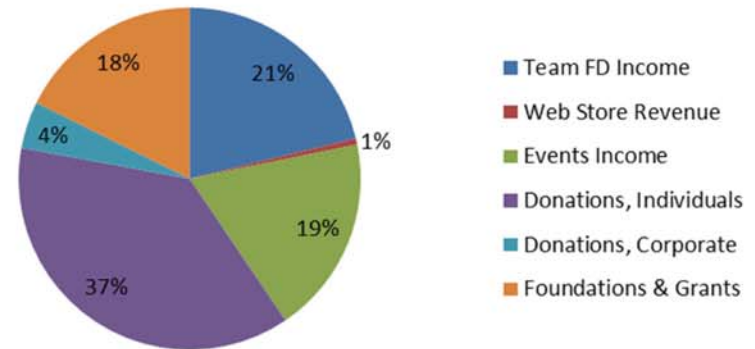

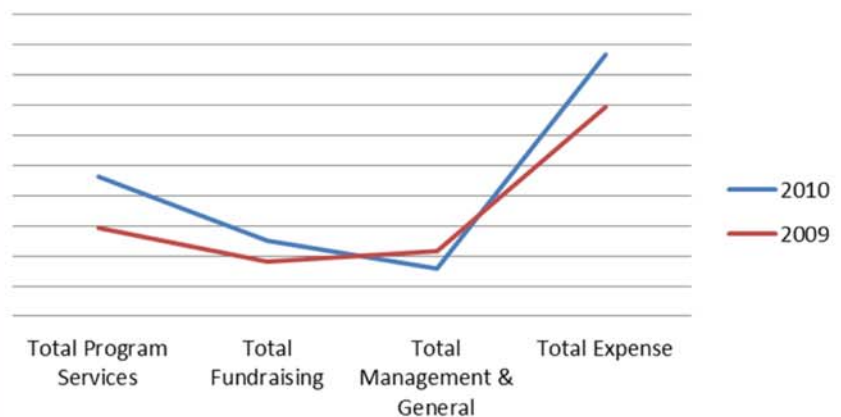
