During the First Descents experience, young adults impacted by cancer and other serious health conditions are empowered through conquering legitimate outdoor challenges to push their limits and face their fears and by doing so, they regain the confidence lost to health conditions. In 2023, First Descents provided 44 week-long programs and 1 multi-day program serving a total of 540 participants. First Descents also served 852 participants through local Community Adventures.
